

## Meth crackdown continues: two more dealers captured

The Central Oregon Drug Enforcement (CODE) team captured two more suspected meth dealers Thursday night, the fourth and fifth such arrests on Thursday alone -â€“ bringing the total thus far in 2007 to 26.

CODE team member Jim Porter, a lieutenant with the Bend Police department, says that this yearâ€™s concentrated effort to crackdown on drug sales in Central Oregon has resulted in 14 drug raids; the arrest of 26 suspected dealers; and the seizure of over ten pounds of methamphetamine, 460 marijuana plants, ten and one-half pounds of marijuana, and over \$43,000 cash. The meth seized has a street value of over \$470,000; and the processed marijuana over \$30,000, Porter estimates.

As a result of the last two arrests on Thursday, Arturo Ponce-Cabrera and Moises Hernandez are in custody on various drug charges.

Ponce-Cabrera, 30, of Salem, was first identified in March 2005 as being involved in delivering large quantities of meth to mid-level dealers in Central Oregon. He was arrested April 30 as he was selling one-half pound of meth to a police operative, Porter said, and in August 2005 was sentenced to 14 months in state prison.

On Tuesday of this week, detectives collected sufficient evidence via surveillance and interviews that â€œclearly indicatedâ€• that Ponce-Cabrera was once again dealing large quantities of meth, despite being on parole from his previous conviction.

On Wednesday, detectives found out that the suspect would be delivering a large shipment the following day.

Detectives staked out several locations that Ponce-Cabrera was known to frequent, Porter said, and the suspect was observed driving a rental car near East Highway 20 and SE 27th Street in Bend about 7:30 p.m. on Thursday. The vehicle was also occupied by one passenger, Porter said, who was later identified as 22-year old Madras resident Moises Hernandez.

Detectives watched Ponce-Cabrera apparently sell drugs, and both he and Hernandez were taken into custody near the intersection of Highway 20 and Benson Way. Detectives seized two ounces of methamphetamine and \$3,100 in cash, the lieutenant said, and found that both men had keys to a room in Redmond's Super-8 Motel, located at 3629 SW 21st Place.

At 11:45 p.m. that night, detectives obtained and executed a search warrant on the motel room that the suspects shared, seizing an additional five ounces of meth, and weight scales, Lt. Porter said.

Ponce-Cabrera and Hernandez are lodged in the Deschutes County Jail and face charges of possession, manufacturing, and delivery of methamphetamine.
