State Plumbing Board: Dewey Darold, of Tualatin, fills the position for Health Division Official. He is the current program coordinator for the State of Oregon's Cross Connection/Backflow Prevention Program. Oregon State Veterinary Medical Examining Board: Dr. Lauren Acton is a veterinarian from Woodburn. She is a current member of the American Dairy Goat Association and she has formerly served on the Oregon Racing Commission. Trimet Board: Richard Van Beveren of Hillsboro will fill the vacancy in District 1. He is active in the Hillsboro Chamber of Commerce, Hillsboro Schools Foundation and the Hillsboro Community Foundation. He has also served on the South Hillsboro Design Task Force and as Director of the Portland Rose Festival Association.
