

Central Oregon receives \$214,481 in OLCC February liquor revenue

Crook, Deschutes, Gilliam, Hood River, Jefferson, Klamath, Lake, Sherman, Wasco and Wheeler counties and their 32 cities received \$214,481 in February in the Oregon Liquor Control Commission's (OLCC's) statewide liquor revenue allocation.

Here's the distribution by county:

The agency distributed \$10.3 million statewide in February, using a per capita formula based on Oregon's population of 3.69 million -- 26 cents per person for counties; 76 cents a person for cities. The 36 counties received 10 percent of the total, \$971,860; 239 cities, 20 percent, \$1.9 million; state general fund, 56 percent, \$5.4 million; and city revenue sharing account, 14 percent, \$1.36 million. In addition, the state Addiction and Mental Health Division received \$540,339 and the Oregon Wine Board got \$17,183.

OLCC revenue is derived from the sale of distilled spirits in 241 liquor stores, taxes on malt beverages and wine, license fees, and fines for liquor law violations. Last month's revenue share was \$8.3 million.

The OLCC collects privilege taxes of \$2.60 for a 31-gallon barrel of malt beverage, 67 cents a gallon for taxable wine with an alcohol content of 14 percent or under and 77 cents on taxable wine over 14 percent. Of that, 2 cents a gallon goes to the Oregon Wine Board to fund research and promotion.
